- The hire charge will be paid in full in accordance with the "Total Cost" listed above. Prior to the "Date Out" date listed above and as such, before any equipment leaves AirEye Ltd. premises.
- All hire equipment shall remain the property of AirEye Ltd.
- It is the responsibility of the hirer to ensure that all hired equipment is in suitable working order. This shall be recorded in the "Condition" section mentioned above and shall be agreed upon with the signing of this document.
- AirEye Ltd. will not be held responsible in the event that hired equipment is deemed unfit for the purpose of the hirer.
- The hirer acknowledges that AirEye Ltd. does not provide any insurance for the hired equipment.
- The hirer accepts full responsibility of the protection and maintenance of the hired equipment between (and inclusive of) the "Date Out" and "Date In" dates listed above. As such, the hirer agrees to compensate AirEye Ltd. to the full current market value (or appropriate repair cost) of any equipment that is damaged or lost within the aforementioned dates.
- The hirer will notify AirEye Ltd. of any loss or damage to hired equipment within 24 hours of either being sustained.
- In the event of loss or damage of hired equipment, the hirer agrees to compensate AirEye Ltd. for potential loss of earnings over the period of time taken to repair or replace the hired equipment. The cost of which will be equivalent to the listed AirEye Ltd. day rate, multiplied by the number of days over which AirEye Ltd is without said equipment.
- The hirer has insurance (or funds available) adequate enough to fully compensate AirEye Ltd. in the manner listed above in the event of any damage or loss of hired equipment.
- AirEye Ltd. is not liable in any way for misuse by the hirer of the hired equipment.
- The hirer indemnifies AirEye Ltd. of any legal action (inclusive of but not limited to costs, demand or liabilities) related to the hired equipment and its use.
